## Survey Contest Rules

### **How to Enter:**

No purchase necessary. To enter the contest the entrant must complete the survey either online via the UFSC website (ufsc.ca), twitter page (@ufsc\_insurance), or by requesting the paper format by calling 1.204.586.4482 or 1.800.988.8372.

Entrants must submit a valid phone number and email address.

To be valid, entries must be received by midnight (24:00) central time on the following draw deadlines:

- March 31, 2017
- June 30, 2017
- September 30, 2017
- December 31, 2017

Limit of one entry per person for each draw deadline as stated above. All duplicate entries per draw deadline will be discarded.

Odds of winning is depends on the number of eligible entries per draw deadline.

By entering, you agree to abide by the contest rules.

### **Prize Description:**

The winner will receive one (1) \$100 MasterCard gift card.

The prize cannot be exchanged for the cash value.

If the prize cannot be awarded as described in these rules, UFSC has the right to substitute the prize with another of equal value.

### **Eligibility Criteria:**

Entrants must be at least 18 years of age and a Canadian resident.

Quebec residents are not eligible to participate in this contest.
